+ Participate

We recognises the central role of families in participant's lives, and that family life, and family priorities and choices, drive what happens in service planning and provision. To promote a shared ownership model, we will ensure that:

- P1 we will embrace and align our practice with a family-centred and strengths-based approach;
- P2 every participant will be treated as an individual and intervention processes will reflect their preferences, priorities, learning styles and cultural beliefs;
- P3 interventions with participants will be based on validated practices and best available research;
- P4 we will have clear governance arrangements that create an organisational culture that fosters participant safety and wellbeing;
- P5 we will guide families through the early and ongoing experiences of having a child with a disability;
- P6 we will continue to create opportunities and initiatives that support participants achieve their objectives.



+ Educate & Advocate

To enhance our reach and reputation, to support service delivery improvement, and to raise community awareness more broadly, we will:

EA1 design and deliver a range of professional development training programs for participants, families, and allied health professionals;

EA2 ensure training materials are easily accessible and available in a variety of formats;

EA3 prioritise participant perspective in content creation and program delivery;

EA4 curate and convene a bi-annual conference of national significance;

EA5 support specialist research activity, and its translation, to positively impact participants and their families in day-to-day life;

ensure that our involvement in research is collaborative in design and practice, values knowledge generated in different ways, builds on existing knowledge, aligned with preferred areas of activity, and places a high value on participant perspectives;

EA7 publish, in a variety of formats, and in systematic ways, ideas and stories that are meaningful to participants, their families, and the broader public.

To embrace the opportunity and responsibility to advance issues that are in the interests of young people with disabilities, we will:

EA8 publicly speak or act in favour or against matters of policy or practice impacting a person's ability, regardless of their needs, to participate fully in their family and community life, and to have the same choices, opportunities and experiences as other people;

EA9 lend support to participants who are self-advocating and in need of organisational assistance;

EA10 implement and model inclusive practices within all areas of our work.
